AND SOME DAY BENJAMIN WILL LEARN THAT IN OUR EYES HIS MOM IS A REAL-LIFE SUPERHERO, WHO LIFTED UP SOME OF OUR COUNTRY'S GREATEST HEROES, AND HE WILL BE AS PROUD OF HER AS WE ARE TODAY. WITHOUT FURTHER ADIEU, ON BEHALF OF THE FLORIDA BAR YOUNG LAWYERS DIGS, I WOULD LIKE TO DIVISION AND INVITE MISS STOCKER TO JOIN ME AND PRESENT TO HER THE FLORIDA BAR YOUNG LAWYERS DIVISION, PRESTIGIOUS PRO BONO SERVICE AWARD.

AND I REMEMBER FEELING, LIKE WE WERE HOMELESS, LIKE, WE WERE UNSAFE, AND UNCERTAIN ABOUT WHAT WE WOULD COME HOME TO, OR IF WE WOULD COME HOME TO ANYTHING AT ALL?

MY TIME AND EFFORT IN THE ABILITY HOUSING CASE WAS WITH ONE GOAL IN MIND, AND IT WAS TO HELP FIGHT FOR THOSE 12 CITIZENS THAT WOULD NOT HAVE THE OPPORTUNITY TO LIVE IN THE COTTAGE AVENUE APARTMENTS IN SPRINGFIELD.

TO HELP PROVIDE THEM WITH THE BASIC LUXURIES THAT WE PROBABLY ALL TAKE FOR GRANTED.

A ROOF OVER OUR HEAD, A SAFE PLACE TO SLEEP, ACCESS TO MEDICAL CARE, AND ACCESS TO TRANSPORTATION AND FOOD. WORKING ON THIS CASE TAUGHT ME A LOT ABOUT PERMANENT SUPPORTIVE HOUSING AND WHAT A LASTING IMPACT THAT CAN MAKE ON ONE PERSON'S LIFE AND THEIR WELL-BEING.

BECAUSE IF YOU'RE NOT, IF YOU'RE WORRIED ABOUT WHERE YOU'RE GOING TO SLEEP AT NIGHT, OR WHERE YOUR NEXT MEAL IS GOING TO COME FROM, OR IF YOU'RE SUFFERING FROM AN UNTREATED MENTAL ILLNESS, YOU CAN'T POSSIBLY FOCUS ON ANYTHING ELSE.

YOU CAN'T THINK ABOUT GETTING A JOB, YOU CAN'T WORRY ABOUT KEEPING YOUR HOME CLEAN, YOU CAN'T THINK ABOUT GIVING BACK TO YOUR COMMUNITY OR DOING PRO BONO SERVICE.

YOUR FOCUS IS ONLY ON YOUR IMMEDIATE NEEDS, SAFE SHELTER, FOOD, AND ACCESS TO MEDICAL CARE.

WORKING WITH ABILITY HOUSING AND ACHIEVING WHAT WE DID FOR THE JACKSONVILLE COMMUNITY AND FOR OTHERS WHO FACE HOUSING DISCRIMINATION, FOR THEIR DISABILITIES WAS SUCH A HUGE REWARD IN AND OF ITSELF FOR ME. SO NOW, I HOPE THAT BY RECEIVING THIS AWARD, I CAN HELP BRING AWARENESS EVEN TO JUST ONE PERSON ABOUT WHAT PERMANENT SUPPORTIVE HOUSING IS, AND WHAT A LASTING IMPACT IT CAN HAVE ON SOMEONE'S LIFE AND THEIR WELL BEING.

I HOPE BY RECEIVING THIS AWARD TODAY, I HAVE INSPIRED OTHERS TO DO THE PRO BONO SERVICE AND GET THE IMMENSE SATISFACTION THAT I RECEIVED JUST FROM WORKING WITH THESE PEOPLE AND AS GREG SAID BEFORE, I'M TAKING THIS AWARD AND I'M RECEIVING IT FOR THE TEAM BECAUSE THIS WAS CERTAINLY NOT AN INDIVIDUAL EFFORT AND I COULDN'T BE HERE TODAY, ACCEPTING THIS AWARD IF IT

WEREN'T FOR THE SUPPORT OF EVERYONE AT AKERMAN AND EVERYONE AT ABILITY HOUSING AND ALL THE WONDERFUL WORK WE DID TOGETHER. SO THANK YOU VERY MUCH. [APPLAUSE] >> NOW, I TURN TO THE--[INAUDIBLE] MY PLEASURE TO ANNOUNCE THIS YEAR'S-- [INAUDIBLE] NOW IT IS ON. IT IS MY PLEASURE TO ANNOUNCE THIS YEAR'S RECIPIENT OF THE FLORIDA LEGAL PROFESSION'S HIGHEST PUBLIC SERVICE HONOR. THE TOBIAS SIMON PRO BONO SERVICE AWARD. THIS YEAR'S AWARD GOES TO STEPHEN M. TODD OF TAMPA. [APPLAUSE] IN 2006, MR. TODD ATTENDED A BENCH BAR SEMINAR AT WHICH 13th CIRCUIT CHIEF JUDGE EMANUEL MENENDEZ, JR., ENCOURAGED LAWYERS TO ENGAGE IN PRO BONO SERVICE. MR. TODD ALSO NOTICED THE ONE BUTTON PART OF A CAMPAIGN TO GET EACH LAWYER TO ACCEPT ONE PRO BONO CASE ON THE LAPEL OF THEN JUDGE JAMES BARTON II. INSPIRED, MR. TODD BECAME A GUARDIAN AD LITEM. SINCE THEN, HE HAS FOUND THAT THE CHILDREN AND THE FAMILY SITUATIONS HELP HIM UNDERSTAND THAT LIFE IS ABOUT SERVING OTHERS. HIS SERVICE HAS BEEN OFFERED PRIMARILY TO FOUR ORGANIZATIONS. ONE HE JOINED CROSSROADS FOR FLORIDA KIDS IN 2012. EVEN HIS CLIENTS RUNAWAY OR COMMIT CRIMES, EVEN IF HIS CLIENTS RUN AWAY OR COMMIT CRIMES, HE STANDS BY THEM. MR. TODD HAS SERVED AS GUARDIAN AD LITEM FOR MORE THAN 20 CHILDREN SINCE 2007. HE IS NOW A MASTER GUARDIAN

AD LITEM, A NEW PROGRAM IN WHICH NEW GUARDIANS ARE ASSIGNED TO MORE EXPERIENCED GUARDIANS. TWO, AND THREE, HE ALSO MENTORED YOUNGER LAWYERS THROUGH THE HILLSBOROUGH COUNTY BAR ASSOCIATION'S MENTORING PROGRAM. AND FOUR, IN THE HILLSBOROUGH COUNTY ATTORNEY'S OFFICE HE HELPED ORGANIZE A HILLSBOROUGH COUNTY ATTORNEY INTAKE NIGHT AT BAY AREA LEGAL SERVICES. DURING HIS 27 YEARS AS A MEMBER OF THE FLORIDA BAR, MR. TODD HAS DONATED MORE THAN 2,000 HOURS OF PRO BONO SERVICE. HE WROTE, IN ADDITION TO UNDERSTANDING THAT PRO BONO IS AN OBLIGATION, I HAVE DISCOVERED SOMETHING PROFOUNDLY MORE IMPORTANT AS I HAVE CONTINUED TO WORK FOR CHILDREN AS A CROSSROADS ATTORNEY. I HAVE COME TO REALIZE THAT IT IS THE CHILDREN AND THEIR FAMILIES WHO BLESS ME AND HELP ME TO GROW BOTH AS AN ATTORNEY AND AS A PERSON. I CAN NOT NAME ALL OF THE ACCOMPLISHMENTS AND HONORS IN THE TIME THAT I HAVE HERE TODAY BUT I URGE ALL OF YOU AGAIN TO READ ABOUT THEM IN THE BOOKLET AVAILABLE HERE. IT IS MY PLEASURE TO ASK MR. TODD TO APPROACH THE BENCH AND RECEIVE THE AWARD, SHAKE THE HANDS OF THE JUSTICES AND PROCEED TO THE PODIUM FOR REMARKS. MR. TODD. [APPLAUSE] >> CHIEF JUSTICE LABARGA, JUSTICE, THANK YOU VERY MUCH. THANK YOU AS WELL TO THE COMMITTEE AND TO ROSEMARY ARMSTRONG. WHERE IS ROW MARY, FOR NOMINATING ME FOR THIS AWARD. I'D LIKE TO START WITH A

SHOUTOUT TO MY SON ABLE WHO IS HERE TODAY AND HORRIFY HIM. TODAY IS HIS 16TH BIRTHDAY. [LAUGHTER].

SEW CHOSE TO, WELL, SORT OF CHOSE TO COME ALONG WITH HIS OLD MAN TO THIS EVENT, AND I AM VERY GRATEFUL THAT HE IS HERE.
TO BORROW THE SLOGAN OF THE GUARDIAN AD LITEM PROGRAM, FOR JUST A MOMENT AND I'M DOING SO WITH PERMISSION I'M TOLD, I DO PRO BONO WORK AS AN ADVOCATE FOR CHILDREN BECAUSE I AM FOR THE CHILD.

THAT'S MY PURPOSE IN DOING PRO BONO.

THAT'S NYE NICHE.

EACH ONE OF YOU NEEDS TO FIND YOUR OWN NICHE IF YOU HAVE NOT ALREADY TO FIND THAT AREA OF PRO BONO WHERE YOU CAN SERVE, SERVING THE CHILDREN HAPPENS TO BE MINE.

ALONG THOSE LINES I WOULD LIKE TO TALK ABOUT AN AREA IN OUR SOCIETY WHICH IS A GROWING PROBLEM AND TO SUGGEST A SOLUTION TO THE PROBLEM. THE PROBLEM IS, THAT THERE IS AN EPIDEMIC OF CHILD NEGLECT AND ABUSE IN OUR STATE, IN OUR NATION.

AND THE PROBLEM IS GETTING WORSE.

EVERY WEEKDAY IN COURTROOMS IN FLORIDA ARE JAM-PACKED WITH CHILDREN AND THEIR CAREGIVERS LOOKING FOR SOLUTIONS FROM AN OVERWORKED COURT SYSTEM. HERE ARE JUST A COUPLE OF THE CASES THAT I DEALT WITH THAT ARE COMMONPLACE.

I WENT TO VISIT ONE HOME WHICH WAS A REALLY DISGUSTING HOTEL ROOM, WHERE THE MOTHER WAS THERE WITH HER THREE SMALL CHILDREN. THE MOTHER WAS SO DRUGGED BY FENTANYL AND OXYCODONE, THAT SHE COULDN'T GET UP TO FEED HER

CHILDREN.

I REPRESENT ANOTHER CHILD WHOSE MOTHER'S METHOD OF DISCIPLINE WAS TO TAKE HIS HEAD AND RAM IT AGAINST THE WALL UNTIL HE WAS UNCONSCIOUS.

CASES LIKE THESE ARE HAPPENING EVERY DAY IN OUR STATE. WE CAN'T TURN A BLIND EYE TO

THEM.

CASEWORKERS ARE OVERWHELMED.
I KNOW ONE DEDICATED CASEWORKER
WHO TOLD ME THAT SHE IS ASSIGNED
TO WORK ON 34 CASES.
SHE SAID THAT SHE IS SO BUSY,
THAT SHE CONSIDERS HER OWN
11-YEAR-OLD SON TO BE HER
35th CASE AND SHE WAS
SERIOUS.

IN HILLSBOROUGH COUNTY ALONE IN 2017, 1650 CHILDREN WERE SHELTERED DURING THE YEAR. THAT IS FOUR CHILDREN PER DAY, REMOVED FROM THEIR HOMES, PLACED INTO AN UNFAMILIAR SYSTEM, REQUIRING THAT THERE BE A CASE WORKED AND THAT IS JUST HILLSBOROUGH COUNTY. EACH OF THESE CHILDREN NEEDS AN ADVOCATE.

A STARTING POINT TO HELP DEAL WITH THIS EPIDEMIC PROBLEM IS THAT MANY PEOPLE STAND UP AND SAY, I AM FOR THE CHILD AND THEN ACT ON IT.

I SEE FLORIDA'S 100,000 ATTORNEYS AS A POTENTIAL ARMY OF VOLUNTEERS UNIQUELY SITUATED TO STEP UP AND TO HELP THE CHILDREN IN OUR STATE.

I'M HERE TO TELL YOU THAT EVERY LAWYER IN FLORIDA HAS GREAT POTENTIAL DUE TO OUR EDUCATION, TO OUR DIVERSITY, TO OUR PASSION TO HELP CLIENTS, TO OUR ABILITIES IN DIFFERENT AREAS, TO DO PRO BONO WORK, NOT ONLY WORKING FOR CHILDREN, BUT WORKING IN YOUR AREA OF EXPERTISE.

THE 2012 ROSEMARY ARMSTRONG WON THE SAME AWARD AND STARTED AN ORGANIZATION CALLED CROSSROADS FOR FLORIDA KIDS, IN WHICH SHE IS RECRUITED UPWARDS OF 70 ATTORNEYS IN THE TAMPA BAY AREA TO GO TO COURT AND BE ADVOCATES FOR CHILDREN IN TAMPA BAY. ROSEMARY ASKED ME TO TAKE ONE DEPENDENCY CASE BACK IN 2012 AND I DID AND I REMEMBER SOMEBODY SPOKE EARLIER AND SAID SHE COULDN'T SAY NO.

- I THINK ALL OF US WORKING IN PRO BONO HAVE THAT QUALITY. WE'RE JUST UNABLE TO SAY NO AND I DEFINITELY CAN'T SAY NO TO ROSEMARY ARMSTRONG.
- I TOOK ANOTHER CASE AND THEN ANOTHER.
- I BECAME MORE COMFORTABLE DOING THE TYPE OF WORK THAT WE WERE DOING ADVOCATING FOR CHILDREN, AND I HAVE TO ADMIT THAT I ENJOY AND HAVE ENJOYED EVERY MINUTE OF IT.
- IN SPITE OF THE TRAGEDIES THAT I SEE.
- AND AS THE CHIEF JUSTICE SAID, EACH CASE I HANDLE HELPS ME TO GROW AS A PERSON.
- I REALIZED AFTER A WHILE, I CAN'T FIX EVERYTHING IN THESE CHILDREN'S LIVES.
- THEY WERE A MESS BEFORE I GOT THERE.
- THEY WILL BE A MESS AFTER I LEAVE BUT I CAN DO A LITTLE BIT FOR THEM.
- I CAN LISTEN TO THEM.
- I CAN BE TEAR ADVOCATE WHEN NO ONE EVER AD VOTE INDICATED FOR THEM.
- I CAN SHOW THEM WHAT IT MEANS TO CARE.
- I CAN GIVE THEM MY BEST ADVICE.
 I CAN DESCRIBE FOR THE JUDGE
 WHAT IS REALLY GOING ON IN THAT
 CHILD'S LIFE SO I AM THE EYES OF
 THE JUDGE IN THAT CHILD'S HOME.

SO THERE IS A LITTLE BIT I OR EVERY PRO BONO LAWYER CAN DO TO HELP.

MY FAVORITE CLIENT IS JUSTIN.
ROSEMARY ASSIGNED ME TO HELP
JUSTIN WHEN HE WAS 17 YEARS OLD.
HE IS NOW 19.

HIS PARENTS LOST PARENTAL RIGHTS WHEN HE WAS MUCH YOUNGER. HE WAS BOUNCING BETWEEN TEMPORARY HOMES.

HE LACKED GUIDANCE IN HIS LIFE. I LIKE JUSTIN BECAUSE HE HAS SUCH A POSITIVE ATTITUDE. SO I HELPED HIM TO NAVIGATE THROUGH THE COURT SYSTEM, AND THEN I HELPED HIM TO MAKE SOME LIFE CHOICES WHEN HE TURNED 18. HIS LATEST PROBLEM WAS HE WAS STOPPED BY POLICE, RECEIVED A TICKET FOR DRIVING WITHOUT A LICENSE.

AND I SAID, JUSTIN, WHY DON'T YOU GET YOUR DRIVER'S LICENSE? AND I FOUND OUT HE HAD A LEARNING DISABILITY, HE STRUGGLED TO STUDY FOR THE TEST. I THOUGHT IT WOULD BE JUST WORTH IT TO DRIVE WITHOUT TAKING THE TEST.

SO I SAT DOWN WITH HIM AND I HELPED HIM STUDY FOR THE DRIVING TEST.

HE KEPT PUTTING IT OFF.
HE FINALLY PASSED IT THIS PAST
DECEMBER.

THE CHARGES AGAINST HIM WERE DISMISSED BY THE COURT.
YOU CAN SEE IN HIS EYES HOW THAT EMPOWERED HIM JUST TO HAVE A DRIVER'S LICENSE, TO GET A JOB AND DRIVE TO THAT JOB.
IT IS HOW JUSTIN ENRICHED ME THROUGHOUT MY TIME WITH HIM, THAT IS SPECIAL TO ME.
HE IMAGINES HIMSELF AS A LADY'S MAN.

[LAUGHTER].

HE IS CONSTANTLY WORRIED ABOUT HIS HAIR.

HE TOLD ME VERY CONFIDENTIALLY
THIS PAST DECEMBER THAT HE IS AN
EXPERT IN COLOGNES AND HE
LECTURED ME ABOUT HOW TO APPLY
COLOGNES IN THE PROPER MANNER.
SO THERE IS NO WAY IN 2006, WHEN
I STARTED ON THIS JOURNEY I
COULD HAVE IMAGINED THAT I WOULD
BE ENRICHED BY SPENDING TIME
WITH A 19-YEAR-OLD WHO IS
LECTURING ME ON HOW TO APPLY
COLOGNES.

THESE CASES CAN BE VERY SAD BUT LIKEWISE VERY REWARDING. YOU CAN ACCOMPLISH SO MUCH FOR A CHILD BY DOING SO VERY LITTLE FOR A CHILD.

ONE PLACE TO START IS SIMPLY TO SAY I WILL JUST TAKE ONE CASE, IN 2018.

JUST ONE.

THAT IS YOUR RESOLUTION FOR THE REST OF THE YEAR.

I WILL MENTOR JUST ONE CHILD FOR 2018.

I COULD NOT DO PRO BONO WITHOUT THE ENCOURAGEMENT AND SUPPORT OF MY BOSS, CHIP FLETCHER, AND MY SUPERVISING ATTORNEY ROB BRAZEL. I'M GRATEFUL ROB IS HERE TODAY AND GENERAL ANY TARR WHO HIRED ME ALL THOSE YEARS AGO IN OUR OFFICE, I'M GLAD YOU'RE HERE AND RUDY FROM OUR OFFICE.

MAYBE YOUR ROLE WOULD BE TO

ENCOURAGE OTHERS TO TAKE ONE CASE THIS YEAR.

THIS IS THE ESSENCE OF, THE VERY ESSENCE OF THE RULE OF LAW, WHICH HAS MADE THIS NATION GREAT.

IN THIS VEIN LET ME GIVE A LAST ROUND OF APPLAUSE FOR ALL OF OUR AWARD WINNERS HERE TODAY. [APPLAUSE]

ON A FINAL NOTE WE INVITE EVERYONE HERE WHO IS NOT AN AWARD WINNER, TO PROCEED TO THE ROTUNDA FOR A RECEPTION CELEBRATING THE ACCOMPLISHMENTS OF THIS YEAR'S RECIPIENTS. AND WE ASK THAT A RECIPIENTS REMAIN HERE IN THE COURTROOM FOR PHOTOGRAPHS.

YOU WILL LATER JOIN OUR GUESTS IN THE IN ROTUNDA, AND HAVE WHATEVER IS LEFT FOR YOU THERE. [LAUGHTER].
